# **Amendment 2017-1-B-WSFWP-1**

**Request:** Text amendments to adopt the 10-Year Water Supply Facilities Work Plan (FY 2017-18 – FY 2027-28) which identifies updated alternative and traditional water supply development projects and conservation and reuse activities needed to meet projected future water demands.

**District:** Countywide



# **Amendment 2017-1-B-WSFWP-1**

## **10 Year Water Supply Facilities Plan:**

- **Examine water supply demands within unincorporated county**
- **Inventory of needed facilities for 10 year period**
- **Coordinate with WMD plans**

**per s. 163.3177(6)(c)3, F.S.**

**Need for out-of-cycle review:**

**Adopt within 18 months of Water Management District plan adoption (Nov. 2015) per 163.3177 F.S.**

**Therefore, adoption no later than May 2017**
