SUBJECT: Reappointments to the Maitland CRA Advisory Board
DISCUSSION AGENDA ITEM MAY 23, 2017

The Maitland CRA Advisory Board ("Advisory Board") was created on August 19, 2003. It is composed of three members, including the Mayor of the City of Maitland and two members appointed by the Board of County Commissioners ("Board"). Currently, Robert H. Gebaide and Robert E. Yohe are the Board's appointees on the Advisory Board; however, their terms have expired. Commissioner Bonilla has requested that Mr. Gebaide and Mr. Yohe be reappointed to the Advisory Board.

In addition, at the January 24, 2017 meeting, the Board discussed the CRA appointment process that was previously approved on February 22, 2005 (see attached). As a follow-up to that discussion, staff will present recommended changes to the appointment process for various city CRA Boards and advisory boards and seek direction on this process. The Board will also be requested to reappoint Mr. Gebaide and Mr. Yohe to the Advisory Board with terms expiring December 31, 2019.

On February 22, 2005, the Board approved the following process for appointing members to all Community Redevelopment Agency (CRA) Boards and CRA Advisory Boards.

- Apopka CRA Board – District 2 Commissioner to submit nominee to Agenda Development for placement on Consent Agenda; Board confirmation required.
- Eatonville CRA Board – District 2 Commissioner to submit one citizen nominee to Agenda Development for placement on Consent Agenda; Board confirmation required.
- Maitland CRA Board – District 5 Commissioner to submit one citizen nominee to Agenda Development for placement on Consent Agenda; Board confirmation required.
- Maitland CRA Advisory Board – District 5 Commissioner to submit two citizen nominees to Agenda Development for placement on Consent Agenda; Board confirmation required.
- Orlando CRA Advisory Board – Mayor to submit one elected official nominee and one citizen nominee to Agenda Development for placement on Consent Agenda; Board confirmation required.
- Winter Garden CRA Board – District 1 Commissioner to submit one citizen nominee to Agenda Development for placement on Consent Agenda; Board confirmation required.
- Winter Park CRA Board – District 5 Commissioner to submit one citizen nominee to Agenda Development for placement on Consent Agenda; Board confirmation required.
