## **RESOLUTION GRANTING PETITION TO VACATE # 17-01-003**

WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate that certain **30 foot wide portion of a drainage easement, containing approximately 19,575 square feet** in Orange County, Florida, as described in attachment.

**WHEREAS**, notice of a public hearing before the Board of County Commissioners on **May 23**, **2017** was published in the *Orlando Sentinel*, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of the **30 foot wide portion of a drainage** easement, containing approximately **19,575 square feet** will not operate to the detriment of Orange County or the public.
