Consideration: Hubbard Construction Planned Development (PD) / Pine Hills Transportation Facility Preliminary Subdivision Plan (PSP) / Development Plan (DP), Case # PSP-16-11-395, submitted in accordance with Sections 34-69 and 30-89 Orange County Code; This Preliminary Subdivision Plan (PSP) is a request to subdivide and expand the existing transportation facility and parking, to include a community learning center / administration building, a bus fleet maintenance building, a bus wash, and a driver's lounge.
