Dear Mr. Baker:

The purpose of this letter is to inform you that a Public Hearing has been scheduled before the Board of County Commissioners on June 20, 2017 to hear the referenced Application(s) to Construct a Semi-Private Boat Ramp and Conservation Area Impact Permit.

Pursuant to Orange County Code, Chapter 15, Article XV, Section 15-605, Subsection (d)(2) "The environmental protection official shall notify the applicant of the date and time of the public hearing and shall direct the applicant to post the property with a notice of the public hearing. The applicant shall place the notice in a conspicuous and easily visible location on the subject property at least thirty (30) days prior to the public hearing."

The subject property shall be posted at the lake and at the roadside of the property with the date, time, location, and description of the public hearing as required by the Ordinance listed above. The deadline for posting the property is May 21, 2017. Please provide verification that the site has been posted in accordance with the requirements once completed.

Additionally, the applicant shall give written notice to all upland property owners on Lake Hancock, as required by the Ordinance, no less than four (4) weeks prior to the public hearing by completing one of following items below:

1. The applicant shall be required to mail such notice of the hearing regarding the proposed boat ramp facility to the required upland owners by certified mail, return receipt requested to EPD; or
2. The applicant shall provide, at least three (3) weeks prior to the public hearing, a notarized affidavit attesting that written notice to each such upland owner has been hand delivered.

The deadline to mail written notification is May 23, 2017 (option 1). The deadline to provide notarized affidavit of written notice (option 2) is May 30, 2017. An example of a written notification is enclosed. Please be prepared to post the property and distribute the public hearing notifications in a timely manner once EPD has confirmed the date of the hearing.

Also enclosed for your use is a map and a mailing list of the property owners on Lake Hancock.

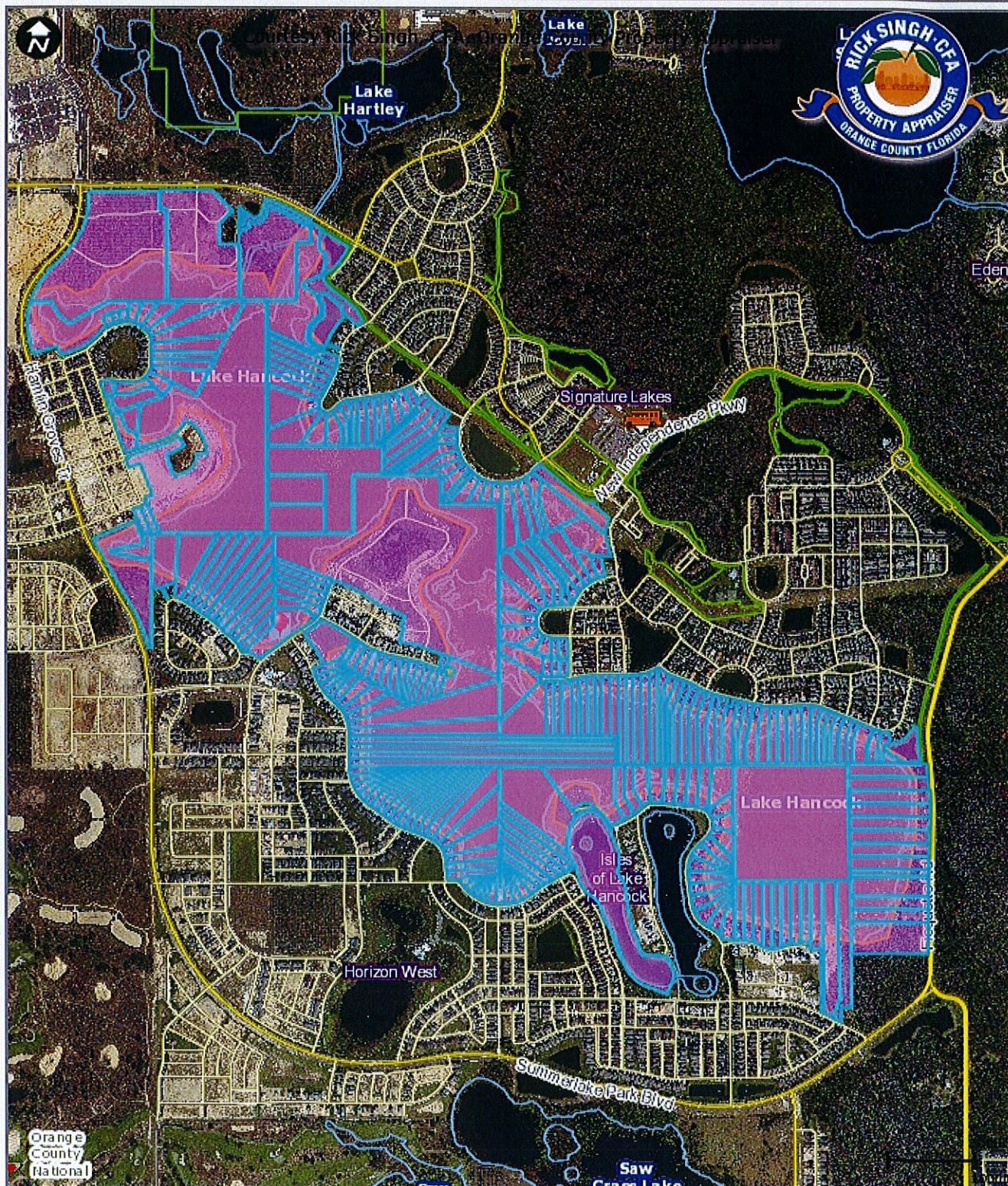
