The Business Development Division evaluated the 5 bids submitted for this project and found that the apparent low bidder R.D. Michaels, Inc. met the MWBE participation goal and reported 47.53% MWBE participation in their bid. Please note the following certified MWBE participation:

The second low bid submitted by McCree Design Builders, Inc. met the MWBE participation goal and reported 35.73% MWBE participation in their bid.

The third low bid submitted by West Construction, Inc. met the MWBE participation goal and reported 32.65% MWBE participation in their bid.

The fourth low bid submitted by Wharton-Smith, Inc. did not achieve good faith effort documentation and reported 18.93% MWBE participation in their bid.

The fifth low bid submitted by Tron Construction, LLC did not achieve good faith effort documentation and reported 3.08% MWBE participation in their bid.



None of the bids met the MWBE sliding scale range criteria to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
