ACTION REQUESTED:

Approval to award Invitation for Bids Y17-735-CH, Lake Pickett Road at North Tanner Road Intersection Improvements, to the low responsible and responsible bidder, Blacktip Services, Incorporated, in the total contract award amount of \$346,359.29.

PROCUREMENT:

The project improvements include the construction of a dedicated 554 feet right-turn lane along westbound Lake Pickett Road at the intersection with North Tanner Road, including milling and resurfacing, grading, stabilized subgrade, soil cement base, and structural and frictional courses. Construction of 4 feet unpaved shoulder, type F curb and gutter, and a 6 foot concrete sidewalk at the intersection are included. The project is located in District 5.

REMARKS:

Four bids were received. The low bid submitted by Blacktip Services, Incorporated is approximately 16% lower than the second low bid. Staff attributed the price difference to current market fluctuations and contractor's means and method. Blacktip Services, Incorporated has a satisfactory record of performance and has been determined responsible. Therefore, award is recommended to Blacktip Services, Incorporated.

The Business Development Division evaluated the 3 lowest bids of the 4 bids submitted for this project and found that the apparent low bidder Blacktip Services, Incorporated did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.

The second low bid submitted by Florida Safety Contractors, Inc. did not achieve good faith effort documentation and reported 12.81% MWBE participation in their bid.

The third low bid submitted by Condor Construction, Corp. did not achieve good faith effort documentation and reported 5.86% MWBE participation in their bid.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
