## **ACTION REQUESTED:**

Approval to award Invitation for Bids Y17-635-TA, Service/Dump Body Trucks, to the low responsive and responsible bidder, Jarrett Gordon Ford, in the total contract award amount of \$197,967.

### PROCUREMENT:

This procurement is for the purchase of three service/dump body trucks to be used for daily operations by the Roads and Drainage Division.

### **FUNDING**:

Funding is available in account number 1002 072 2906 6420.

# **APPROVALS:**

The Roads and Drainage Division and Business Development Division concur with this recommendation.

#### REMARKS:

Three bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Coggin Ford and Prestige Ford were deemed non-responsive for failing to acknowledge addendum 1, which altered the truck specifications, thereby materially impacting the bid document.

Staff has determined the bid price of Jarrett Gordon Ford to be reasonable based on market research and comparison of pricing from the National Joint Powers Alliance (NJPA) Cooperative Contract. The low bidder, Jarett Gordon Ford, meets all specifications and other requirements of the solicitation. Therefore, recommendation for award is made to Jarett Gordon Ford.
