ACTION REQUESTED:

Approval to award Invitation for Bids Y17-158-MV, Exterior Painting and Pressure Washing – Utilities Department, to the low responsive and responsible bidder, Quick Painting Group, Corp. in the estimated contract award amount of \$3,547,500 for a 3-year term. Further request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

PROCUREMENT:

To provide exterior painting and pressure washing services in a variety of buildings and structures for the Utilities Department.

APPROVALS:

The Utilities Department and Business Development Division concur with this recommendation.

REMARKS:

Thirteen bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility and price. The bid of JMD Global Developers was determined to be non-responsible due to unverifiable references.

Extreme Sandblasting & Painting, Inc., and McDine's Painting were deemed non-responsive for failing to submit required addendums.

A timely protest was submitted by JMD Global Developers. A protest review was held by the Procurement Manager and the protest was denied. No appeal was submitted.

The low bidder, Quick Painting Group, Corp., has the necessary manpower and equipment to perform this contract. References contacted demonstrated a satisfactory performance record. Therefore, award is recommended to Quick Painting Group, Corp.
