The advertisement shall be placed in a newspaper of general paid circulation in the County and of general interest and readership in the community pursuant to Chapter 50, not one of limited subject matter. It is the legislative intent that, whenever possible, the advertisement shall appear in a newspaper that is published at least 5 days a week unless the only newspaper in the community is published less than 5 days a week. The advertisement shall contain a geographic location map, which clearly indicates the area within the local government covered by the proposed resolution. The map shall include major Sort. 6.36w. street names as a means of identification of the general area.




