# ACTION REQUESTED:

Approval to award Invitation for Bids Y17-636-PD, Banquet Equipment, to the low responsive and responsible bidder, Louis Wohl and Sons, Inc., for the total amount of \$48,350. Further request approval to purchase additional quantity within 24-months after award, in the amount of \$96,700.

## PROCUREMENT:

To purchase heated banquet carts to store and transport hot plated foods and queen mary racks to transport and store cold food used to support food functions at the Convention Center. The additional quantities may be purchased within a 24-month period after award.

#### FUNDING:

Funding is available in account number 4430-035-0931-6410.

## APPROVALS:

The Convention Center and the Business Development Division concur with this recommendation.

#### **REMARKS:**

Five bids were received in response to this Invitation for Bids and were evaluated for price, responsiveness, and responsibility. Louis Wohl and Sons, Inc. submitted two bids. Bid A submitted by Louis Wohl and Sons, Inc. was for an alternate brand of heated banquet cart on lines 1 and 3, which did not meet the minimum requirements of the bid. Bid B met the specification requirements of the bid. Louis Wohl and Sons, Inc. is the low responsive and responsible bidder on Bid A lines 2 and 4 and Bid B lines 1 and 3.

The bid is considered fair and reasonable based on the technical evaluation and evaluation of staff. Bid tabulation is as follows:
