


#### Cross Connection Control Programs

- Required by Regulations and Industry Standards
  - Florida Administrative Code 62-555 and 62-610
  - Plumbing codes
  - American Water Works Association M14 Manual
- -Established to Protect Public Health
  - Eliminating potential cross connection hazards
  - Installing/maintaining an approved backflow preventer
- Provide a Systematic Way to Manage Risk to the County's Water System



- Types of Cross Connections
  - Irrigation systems
  - —Private wells
  - —Pool equipment
  - Fire systems
  - Industrial/commercial equipment
  - Can be planned or inadvertent







- Preventing Impact From Cross Connections
  - -Eliminate the cross connection
  - Install/maintain an approved backflow preventer device







- Program Developed in 2001; Updated in 2002 and 2009
  - -FDEP inspections identified need for program enhancement
  - -Enforcement challenge
    - Only enforcement option is to discontinue service



- -Customer testing and repair obligations can be burdensome and costly, especially for residential
- -Cross connections must be managed immediately upon discovery



- May 23, 2017 presented proposed cross connection control program changes to the Board
  - Provides for OCU testing, repair, and replacement of residential backflow preventers
  - -Commercial program remains unchanged
- July 18, 2017 preliminary program fee approved
- August 29, 2017 public hearings to approve
  - -Updates to Chapter 37 enabling program changes
  - -Water System Rate Schedule establishing program fee

## Residential Program Revisions

#### Responsibilities

Risk Assessment *County* 

- Remains as a County activity
- No changes needed

Install Device

Customer/County

- Fund current device needs/gaps with a capital project
- Devices for new hazards remain the responsibility of the customer (new homes, adding irrigation systems, etc.)

Test Device **County** 

- County manages testing activity using private contractors
- Funding through existing water rates

Repair or Replace the Device County

- County assumes repair and replacement obligations
- Funding by monthly program fee



#### Residential Program Revisions

#### Revision Benefits

- -Customers are not required to arrange testing/repair
- -Improved compliance rate
- Volume buying power and operational efficiencies
   lower total cost to the customer
- Retain market engagement by using contractors
- -Avoid larger periodic repair costs for customers

- Updated Definitions
- Backflow Preventer Tampering Prohibition
- Cross Connection Inspection Access Rights
- Testing, Repair, and Replacement
  - -County responsibility for residential program
  - -Property owner responsibility for all others



- Residential Program Device Ownership
  - —For existing properties/customers
    - Ownership unchanged until device is replaced
    - Orange County Utilities is granted testing and maintenance authority
  - —For new connections or changes in use
    - Ownership transfers to Orange County Utilities after initial inspection, testing, and acceptance



- Causes for Discontinuing Service
  - Existing cross connection
  - -Tampering with a backflow preventer
  - Denial of property access for
    - Cross connection control hazard inspection
    - Residential device testing and maintenance



- Requires Program Participation for Residential Properties That Are Both:
  - -Individually metered
  - -Required to have a backflow preventer
- Provides For A Program Fee
- Effective Date January 1, 2018

#### Water System Rate Schedule

- Water Rate Resolution
  - Adopts elements of existing rate resolution (2009-M-27)
    - Reflects rates currently in effect
    - Continues to provide for 3% annual adjustment to rates
- Establishes Residential Program Fee
  - -\$3 per month
  - Applicable only to residential properties individually metered and required to have a backflow preventer
  - Not subject to 3% adjustment
  - Effective date January 1, 2018

#### Requested Action #1

Adopt A Resolution Setting A Revised Water System Charge Schedule; Providing For An Automatic Annual Increase; Setting A Water Meter Charge Schedule; Setting A Cross Connection Control Program Fee Effective January 1, 2018; Providing For Periodic Review; Providing For Annual Notice To Customers; Providing For Severability; And Providing For An Effective Date.



#### Requested Action #2

Adopt An Ordinance Pertaining To Water And Wastewater Service In Orange County, Florida; Amending Orange County Code Chapter 37, Article I, Entitled Orange County Water, Wastewater And Reclaimed Water Service Rules; Article III, Entitled Water Wells; Addressing Conflicts Between Ordinances; And Providing For An Effective Date. And Correction Of Scrivener's Error.
