Subject: Award of Invitation for Bids Y17-634-TA, Grapple Roll Off Truck
with Knuckleboom

ACTION REQUESTED:

Approval to award Invitation for Bids, Y17-634-TA, Grapple Roll Off Truck with Knuckleboom, to the low responsive and responsible bidder, Nextran Truck Centers, in the total contract award amount of \$219,064.20.

PROCUREMENT:

This procurement is for the purchase of one Grapple Roll Off Truck with Knuckleboom used for debris pickup at various park locations throughout the County.

FUNDING:

Funding is available in account number 1050-068-1805-6430.

APPROVALS:

The Parks and Recreation Division and the Business Development Division concur with this recommendation.

REMARKS:

Two bids were received in response to the Invitation for Bids and were evaluated for price, responsiveness, and responsibility.

The Parks and Recreation Division is purchasing a new roll off grapple truck with knuckleboom to replace one that was deemed unrepairable and taken off line due to the age and amount spent on repairs. This truck will serve two roles. It will be used to pick up debris piles at 103 park locations and will also serve as a roll off dumpster truck.

Award of Invitation for Bids Y17-634-TA, Grapple Roll Off Truck with Knuckleboom

Since 2004, the County has used a contract for retaining roll-off dumpsters in case of a hurricane or emergency storm damage. The procurement of this vehicle will allow the County to not be dependent on the contract and will result in an annual savings of \$18,000.

Price reasonableness has been determined based on market research that includes price comparison of similar equipment using the Florida Sheriff's Association and National Joint Powers Alliance contracts.
