## **RECOMMENDATION:**

Selection of Standard Insurance Company, to provide Group Term Life, Long and Short Term Disability, and Accidental Death and Dismemberment, for Orange County, Request for Proposals Y17-1068-LC, for a 3-year term.

Further request authority for the Procurement Division to renew the contract for two additional 1-year terms. This item was evaluated and approved by the Procurement Committee on August 9, 2017. Commissioner Betsy VanderLey was assigned to the procurement committee.

## PURPOSE

To provide Group Term Life, Long and Short Term Disability, and Accidental Death and Dismemberment for the employee benefits plan.

## DISCUSSION

The Procurement Committee evaluated the proposals with assistance from the County's benefits consultant, Robinson Bush. The Committee unanimously concluded that Standard Insurance Company was the most highly qualified firm to provide these services. Standard Insurance Company is the current provider and there have been no service or administrative issues.

Five proposals were received in response to this Request for Proposals. The proposals from Aetna Life Insurance Company, Lincoln Financial Group, and Metropolitan Life Insurance did not meet mandatory requirements and were deemed nonresponsive.

The proposal of Reliance Standard scored too low for Board consideration.
