The Orange County Sheriff's Office is requesting \$2,500 from the FY 2017 Law Enforcement Trust Fund for the following purpose:

Contribution:

Boy Scouts of America, Central Florida Council - \$2,500. The Boy Scouts of America's mission is to provide at-risk youth who desperately need guidance and role models with a quality scouting program that will enable them to recognize and reach their full potential by making the right choices to accomplish their goals, to see what they can become through making the right choices, by working hard, and opening their eyes to possibilities of a more constructive lifestyle.

- ACTION REQUESTED: Approval for the Orange County Sheriff's Office to spend \$2,500 from the FY 2017 Law Enforcement Trust Fund to provide an eligible contribution to the Boy Scouts of America, Central Florida Council.
- PLEASE NOTE: The Board voted to establish spending limits of 20% for this fund for contributions. At this point in the fiscal year, contributions represent 40% of the total expenditures; however, the restriction applies to total expenditures for the year, at year-end. The Sheriff's Office has stated that they monitor their expenditures, and that they will not exceed the 20% total for contributions.
