Conservation Area Impact Permit # CAI-13-11-030 (the "Permit")

issued by Orange County Environmental Protection Division required a Conservation and Access Easement (the "Easement") over the site being

developed. The Easement was approved by the Board of County

Commissioners on April 21, 2015 and subsequently recorded on April 24, 2015. The Permit was modified on March 17, 2017 (the "Permit Modification") to authorize the construction of a spreader swale within an upland buffer area subject to the Easement. The Permit Modification requires the Easement to be modified to remove from the Easement the area within the upland buffer impacted by the spreader swale. This Partial Release of Conservation Easement is being executed in accordance with that requirement.

PARTIAL RELEASE OF CONSERVATION EASEMENT

THIS PARTIAL RELEASE OF CONSERVATION EASEMENT (this "Release") is made by Orange County, a charter county and political subdivision of the State of Florida, whose address is Post Office Box 1393, Orlando, Florida 32802-1393 ("County").

RECITALS:

WHEREAS, Lennar Homes, LLC, a Florida limited liability company ("Lennar"), granted in favor of County a conservation easement, as described in Conservation and Access Easement recorded on April 24, 2015, in Official Records Book 10908, Page 8407, Public Records of Orange County, Florida (the "Conservation Easement") over certain property located in Orange County, Florida in favor of County in accordance with Conservation Area Impact Permit No. 13-11-030; and

WHEREAS, on March 17, 2017, County modified Conservation Area Impact Permit No. 13-11-030 to authorize the construction of a spreader swale within an

upland buffer area subject to the Conservation Easement without requiring any additional mitigation for the impact to the upland buffer area or secondary impact to the conservation area; and

WHEREAS, the modification to Conservation Area Impact Permit No. 13-11-030 requires Lennar to modify the Conservation Easement by removing the area within the upland buffer impacted by the spreader swale from the Conservation Easement; and

WHEREAS, County has agreed to release a portion of the property subject to the Conservation Easement that is impacted by the construction of the spreader swale as authorized by the modification to Conservation Area Impact Permit No. 13-11-030; and

WHEREAS, subsection 704.06(4), Florida Statutes, provides that the holder of a conservation easement may release that conservation easement to the holder of the fee interest; and

WHEREAS, Lennar is the holder of the fee interest to the Conservation Easement.

NOW THEREFORE, in consideration of the above and the mutual covenants, terms, conditions and restrictions contained herein, and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, County hereby agrees as follows:

1. <u>Release</u>. County hereby releases, from the lien and encumbrance of the Conservation Easement the property described in attached Exhibit "A" (the "Released Area") which Released Area will henceforth no longer be considered part of the "Property" as defined in the Conservation Easement. This Release is binding upon and

shall inure to the benefit of Lennar and its successors and assigns. This Release applies only to the real property described in attached Exhibit "A."

Reaffirmation. Except as specifically set forth herein, all provisions of the 2. Conservation Easement shall remain unchanged and in full force and effect. The remainder of the property described in the Conservation Easement is unaffected by this Release and shall continue to be bound by the terms of said Conservation Easement.




