RECOMMENDATION:

Selection of one firm and an alternate to provide Regional History Center Marketing Services, Request for Proposals Y17-1010-KB, from the following firms listed alphabetically:

TK Orlando, LLC Wagner

Further request authority for the Procurement Division to negotiate and execute a three-year contract within a budget amount of \$190,800. The Procurement Division also requests the authority to renew the contract for two additional 1-year terms.

This item was evaluated by the Procurement Committee on August 23, 2017. Commissioner Betsy VanderLey was assigned to the Procurement Committee.

PURPOSE:

To provide marketing services and strategies to assist the Orange County Regional History Center in its efforts to grow attendance and visitors.

DISCUSSION:

Three proposals were received in response to this Request for Proposals (RFP). The proposal of HCP Associates, Inc. scored too low for Board consideration. Funds will be provided on individual purchase orders issued by the Regional History Center on an as-needed basis. The proposals were evaluated by the Procurement Committee in accordance with the criteria set forth in the RFP.
