(1) At least 7 days before the BCC public hearing at 2:00 p.m. on October 31<sup>st</sup>, publish an advertisement in a portion of *The Orlando Sentinel* other than the legal notices or classified advertisement portion describing the ordinance and giving the date, time, and place when the BCC public hearing will be held. The advertisement must be no less than 2 columns wide by 10 inches long and the headline in the advertisement must be in a type no smaller than 18 point.

(2) At least 5 days before the BCC public hearing at 5:01 p.m. on November 14<sup>th</sup>, do the same.
