PROJECT: Wetherbee Road - Phase II (Reserve at Sawgrass - Phase 4C)

## District 4

PURPOSE: To release a portion of a Permanent Fill Slope Easement that is no longer needed.

ITEM: Partial Termination of Easement Agreement

REMARKS: On February 13, 2007, the Board of County Commissioners approved a Permanent Fill Slope Easement Agreement recorded in Official Records Book 9121, Page 1214, which contained a provision for automatic termination at such time as development adjoining the Wetherbee Road right-of-way was elevated to such an extent that a fill slope was no longer needed. Beazer Homes, LLC, successor in title, has requested partial termination of the easement to clear title to the lands currently being developed. The Public Works Department has reviewed the request, approved the plat and acknowledges that the easement is no longer required over the lands lying within the plat of Reserve at Sawgrass Phase 4C, Plat Book 93, Page 131.

## PARTIAL TERMINATION OF EASEMENT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS: That ORANGE COUNTY, a charter county and political subdivision of the state of Florida, the owner and holder of a certain non-exclusive Permanent Fill Slope Easement Agreement executed by Wetherbee Ventures, LLC, a Florida limited liability company, dated the $18^{\text {th }}$ day of August, 2006 and recorded on the $20^{\text {th }}$ day of February, 2007, in Official Records Book 9121, Page 1214, of the Public Records of Orange County, Florida, upon the property situate in the said State and County described as follows, to-wit:
