BY THE COMMISSION:

On September 25, 2017, we issued Order No. PSC-2017-0361-FOF-WS, Final Order approving in part Utilities, Inc.'s application for increase in water and wastewater rates in Charlotte, Highlands, Lake, Lee, Marion, Orange, Pasco, Pinellas, Polk, and Seminole Counties. Due to a scrivener's error on page 221, in Table 64 for Labrador, the refund amount should be changed from \$114,329 to \$83,236.
