A master construction agreement with CSX Transportation, Inc. (CSXT) was executed by the BCC on October 5, 2010. The master agreement governs all county-initiated projects that pass over, under, adjacent to, or at-grade with CSXT's railroad facilities. For county-initiated utility projects, the master agreement allows the use of a utility addendum for each specific utility project.

The utility addendum allows a utility crossing to be constructed under the terms of the master agreement without lengthy negotiation of a separate project agreement. The work to be performed and fees associated with the CSXT crossing are detailed in each project-specific addendum.

Some components of the wastewater collection system along Presidents Drive, from Sand Lake Road to Pump Station #3177, require rehabilitation. This rehabilitation will require the installation of two new pipe crossings of CSXT railroad tracks at CSXT Milepost A 797.17. Per CSXT's current construction requirements, each pipe must be installed within its own casing. Accordingly, a new 24-inch force main will be installed within a 42-inch casing and a new 15-inch gravity sewer will be installed within a 30-inch casing. This utility addendum will authorize the necessary CSXT facility crossings.

CSXT requires the payment of a permit fee for each project-specific addendum that is processed. The permit fee associated with this addendum totals \$19,200 and includes an Application Review Fee of \$7,500, a Railroad Protective Liability fee of \$1,500, and a License Fee of \$10,200.

The Orange County Attorney's Office has reviewed the document and finds it acceptable as to form. Orange County Utilities staff recommends approval.
