## **ACTION REQUESTED:**

Approval to award Invitation for Bids Y18-153-PD, Installation and Replacement of Backflow Prevention Assemblies, to the low responsive and responsible bidders, Nils Humberg Enterprises, LLC dba Ace Flow Control in the estimated contract award amount of \$944,500, Frank Gay Plumbing, Inc. in the estimated contract award amount of \$1,033,456.25 and American Backflow & Fire Services, LLC in the estimated contract award amount of \$1,156,500 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

## PROCUREMENT:

To provide physical installation, replacement and initial testing of backflow preventers on properties of Orange County Utilities customers, including residential irrigation and potable water services that are required to have backflow prevention devices or assemblies.

## **FUNDING**:

Funding will be available in account 4420 038 1576 0001.

The Water Division and Business Development Division concur with this recommendation.

## **REMARKS:**

Five bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility and price. The bid of Groundtek of Central Florida, LLC was determined to be non-responsible for failing to submit similar project experience.

The low bidders, Nils Humberg Enterprises, LLC dba Ace Flow Control, Frank Gay Plumbing, Inc. and American Backflow & Fire Services, LLC, have the necessary manpower and equipment to perform this contract. References contacted demonstrated a satisfactory performance record. Therefore, award is recommended to Nils Humberg Enterprises, LLC dba Ace Flow Control, Frank Gay Plumbing, Inc. and American Backflow & Fire Services, LLC.
