## ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS Regarding AUTHORIZING THE CONVEYANCE OF CERTAIN COUNTY PROPERTY INTERESTS TO THE CITY OF APOPKA, FLORIDA

RESOLUTION NO. 2018- $m$ - OI

WHEREAS, Orange County ("County"), a charter county and political súbdivision of the State of Florida, pursuant to its home rule power and Section 125.38; Florida Statutes, has authority to determine that certain County property is not needed for County purposes and to convey said property, for nominal price or otherwise, to the State of Florida or any political subdivision or agency thereof, or any municipality of the State of Florida, or any corporation or non-profit entity organized for the purposes of promoting community interest and welfare; and

WHEREAS, the County has an interest in a portion of unopened road right-ofway known as Ocoee Apopka Road, referenced in Exhibit "A"; and

WHEREAS, as a result of a realignment by the Central Florida Expressway Authority, such road right-of-way is no longer in use; and

WHEREAS, the City of Apopka, Florida ("City") is requesting the County transfer such road right-of-way to the City; and

WHEREAS, the County has determined that any interest it may have in the road right-of-way should be conveyed to the City, and such conveyance is in the public interest; and

WHEREAS, the City is qualified, as a municipality under the laws of the State of Florida, to receive this County road right-of-way pursuant to Section 125.38, Florida Statutes.

## NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

1. The Board hereby determines that the road right-of-way is not needed for County purposes and that it is in the best interest of Orange County that its interest in the road right-of-way be conveyed to the City.
2. The Board directs that all of the County's right, title, and interest in the above road right-of-way be conveyed to the City and the City will assume all of the County's rights, duties, and obligations associated therewith.
3. The Board directs the Orange County Mayor to execute and deliver a County Deed to effectuate such conveyance, and that staff do all. things necessary and appropriate to conclude this transaction.
4. The Board hereby directs that a certified copy of this Resolution shall be forwarded forthwith to the City.
5. This Resolution shall become effective upon its adoption by the Board.

## DESCRIPTION:

A portion of the right of way of County Road No. 437A as shown on the Orlando Orange County Expressway Authority, Western Beltway, right of way map for State Road No. 429, Section 75320-6460-604 in Section 20, Township 21 South, Range 28 East, Orange County, Florida, being more particularly described as follows:

Commence at the Southeast corner of the Southeast One Quarter of the Northwest One Quarter of Section 20, Township 21 South, Range 28 East, Orange County, Florida; thence South $89^{\circ} 38^{\prime} 00^{\prime \prime}$ West, a distance of 1051.60 feet, along the South line of said Southeast One Quarter of the Northwest One Quarter, to the POINT OF BEGINNING, said point being on the East right of way line of County Road No. 437A as shown on the Orlando Orange County Expressway Authority, Western Beltway, right of way map for State Road No. 429, Section 75320-6460-604; thence South 17*47'49" West, a distance of 163.10 feet, along said East right of way line to a point on a non-tangent curve concave Westerly, having a radius of 1029.93 feet, a central angle of $09^{\circ} 05^{\prime} 51^{\prime \prime}$ and a chord bearing of North $03^{\circ} 45^{\prime} 05^{\prime \prime}$ West, said point being on the Easterly right of way line of the proposed County Road No. 437A re-alignment as shown on a Sketch of Description by Dewberry, dated July 31, 2017; thence from a tangent bearing North $00^{\circ} 47^{\prime} 51^{\prime \prime}$ East, Northerly, a distance of 163.53 feet along the arc of said curve and along said Easterly right of way line to a point on the West right of way line of County Road No. 437A as shown on said Orlando Orange County Expressway Authority right of way map; thence North $17^{\circ} 47^{\prime} 49^{\prime \prime}$ East, a distance of $\lceil 179.03$ feet, along said West right of way line to a point of curvature of a curve concave Southeasterly, having a radius of 984.93 feet and a central angle of $15^{\circ} 00^{\prime} 59^{\prime \prime}$; thence Northeasterly along the arc of said curve and along said West right of way line, a distance of 258.14 feet to a point on a line that is 120.00 feet Southeasterly of and parallel with the Northwesterly line of Parcel 63-144, Parcel "B" as shown on said Sketch of Description; thence North $54^{\circ} 55^{\prime} 51^{\prime \prime}$ East, a distance of 202.50 feet, along said parallel line to a point
