I would like to discuss property, presently owned by Mr. Wayne Harrod. The Harrod property is comprised of three parcels totaling 30.42 acres. The parcels are located in the northeast portion of Orange County just south of the Seminole County border. The parcels are located east of Rocking Horse Road, west of Rouse Road, and south of McCulloch Road. The Little Econlockhatchee River flows north through the parcels.

The site is located within the County's Econlockhatchee River Protection Area. The natural communities that exist on the site are forested uplands (18 acres) and 13 acres of wetland communities. The wetland systems on the property consists of an isolated freshwater marsh and forested wetland system associated with the river. The property is relatively free of invasive species and also contains the historic remnants of the Old Iron Bridge road pilings.

There have been differing levels of discussion regarding the ability for Orange County to acquire this property, over the past two years. I would like to discuss with the Board possible collaboration(s), to preserve this environmentally sensitive area.
