I. EXPLANATION & SUMMARY:

The proposed ordinance relates to fire safety within Orange County, and modifies Chapter 18 of County code, Fire Prevention and Protection. The triannual adoption of the Florida Fire Prevention Code, Sixth Edition on December 31st, 2017 necessitated a review of the current ordinance to ensure it was updated and relevant. The proposed draft language includes adoption of the State Fire Code by the local government upon the triannual state adoption. The indicated modifications relate to changes in the State Fire Code and referenced standards. A new section proposes a burn ban designed to reduce the risk of wildfires during periods of drought conditions. This burn ban is similar to the ones that neighboring counties implement.
