AND REPEALING RESOLUTION NO. 2015-M-41

Resolution No. 2018- M-05

WHEREAS, on November 17, 2015, the Orange County Board of County Commissioners (BCC) adopted Resolution No. 2015-M-41 establishing a no truck or tractor trailer parking zone and tow away zone along the northbound and southbound portions of Avalon Park Boulevard between Tanja King Boulevard and Golden Rain Tree Boulevard in order to mitigate motorist and pedestrian safety concerns;

WHEREAS, in order to further improve safety and reduce the potential for vehicle and pedestrian accidents, the BCC desires to establish a no parking zone and tow away zone for all commercial motor vehicles on the roads that are specified in **Appendix "A"** to this Resolution; and

WHEREAS, in so doing, the BCC desires to repeal Resolution No. 2015-M-41.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

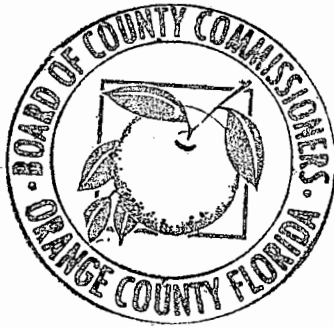
Section 1. Repeal of Resolution No. 2015-M-41. Resolution No. 2015-M-41 is hereby repealed.

Section 2. Establishment of No Parking Zone and Tow Away Zone for Commercial Motor Vehicles. Pursuant to Section 316.1945, Florida Statutes, the Board of County Commissioners hereby establishes a no parking zone and tow away zone for commercial motor vehicles (as defined by Section 316.003(12), Florida

Statutes) on the roads and portions of roads identified in the list attached hereto as **Appendix "A,"** and directs that traffic control signage be installed on those roads informing and warning the public about the no parking zone and tow away zone.

Section 3. Effective Date. This Resolution shall take effect upon the date of its adoption.
