Approval to award Invitation for Bids Y18-174-MV, Temporary Labor – Permit Analyst Building Safety, to the low responsive and responsible bidder, Real Time Services, Inc. dba Top Talent Staffing, in the estimated contract award amount of \$516,975 for a 1-year term. Further, request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

PROCUREMENT:

Permit Analysts perform technical and clerical reviews of building plans and issue permits consistent with department regulations. These are temporary labor positions and are required due to increased permitting activities in the Division of Building Safety.

FUNDING:

REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility and price reasonableness. The lowest responsible and responsible bidder, Real Time Services, Inc. dba Top Talent Staffing, meets all of the requirements of this solicitation. The bid of Moten Tate, Inc. was deemed non-responsive for failing to submit a bid response form. Therefore, recommendation for award is made to Real Time Services, Inc. dba Top Talent Staffing.
