Approval to award Invitation for Bids Y18-721-RM, Morningside Park and Prosper Colony Block E & 2, Phase I Drainage Improvements Project, to the low responsive and responsible bidder, Cathcart Construction Company-Florida LLC in the estimated contract award amount of \$885,990.

PROCUREMENT:

The scope of work includes installation of a baffle box at the south side of the intersection of Lake Christie Drive and Dot Lane, installation of concrete drainage structures & side drains, construction of shallow drainage ditches and the construction of driveways. This project is located in District 6.

APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Although the bid submitted by Cathcart Construction Company-Florida LLC is approximately 10.67% lower than the second low bidder, staff evaluated the bids and determined that the low bid is reasonable. References provided were satisfactory for this type of work and Cathcart Construction Company-Florida LLC has been determined to be responsible. Therefore, award is recommended to Cathcart Construction Company-Florida LLC.

The Business Development Division evaluated the 3 lowest bids of the 6 bids submitted for this project and found that the apparent low bidder Cathcart Construction Company-Florida LLC did not achieve good faith effort documentation and reported 5.59% MWBE participation in their bid. Please note the following certified MWBE participation:

The second low bid submitted by Stage Door II, Inc. did not achieve good faith effort documentation and reported 3.67% MWBE participation in their bid.

The third low bid submitted by Schuller Contractors Incorporated did not achieve good faith effort documentation and reported 5.60% MWBE participation in their bid.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.
