The Neighborhood Preservation and Revitalization Office administers the Neighborhood Pride Grant Program that provides funds for citizen organizations to enhance the quality of their neighborhoods. There has been an overwhelming response from a wide range of neighborhood organizations showing continued interest in the Neighborhood Pride Mini-Grant Program.

The Neighborhood Pride Mini-Grant Program offers small grants to countywide volunteer neighborhood organizations for projects less than \$1,500. The neighborhood organizations are required to attend a mandatory grant workshop and establish a neighborhood team to work with staff on implementing neighborhood projects. The grant applications are accepted from October through June and reviewed monthly by the Neighborhood Grants Advisory Board (NGAB).

The NGAB is recommending approval of three Mini-Grants for Carol Woods HOA: Meadow Woods Village I Neighborhood; and Silver Star Estates Neighborhood (see Attachment A). The grant requests are displayed in greater detail in Attachments B, C and D. The grants were reviewed by County staff and presented to the NGAB for recommendation. The applications were reviewed based on project feasibility, organizational readiness, and benefit to the community.

In addition, the applications were reviewed against the County's permitting requirements to ensure that the projects would comply with appropriate County codes. Finally, the neighborhood organizations were required to demonstrate the ability to maintain the project.


