DONATION AGREEMENT

COUNTY OF ORANGE STATE OF FLORIDA

THIS DONATION AGREEMENT ("Agreement") made between Grande Plaza Maintenance Association, Inc., a Florida non-profit corporation, hereinafter referred to as OWNER, and Orange County, a charter county and political subdivision of the state of Florida, hereinafter referred to as COUNTY.

WITNESSETH:

WHEREAS, the COUNTY requires the land described on Schedule "A" attached hereto ("the Property"), for construction and maintenance of the above referenced project, and said OWNER agrees to furnish said land for such purpose.

In consideration of the sum of One (\$1.00) Dollar, each to the other paid, the parties hereto agree as follows:

- 1. OWNER agrees to convey said lands, known as Parcels 8030.1, 8031.1, 8031A.1, 8031B.1, 8032.1, 8032A.1, 8032B.1, and 8032C.1 of the above referenced project, unto COUNTY by Recreational Trail Easement.
- 2. This transaction shall be closed and the easement and other closing papers delivered on or before 90 days from the effective date of this AGREEMENT. Closing shall take place at the office of the Orange County Real Estate Management Division, 400 E. South Street, Fifth Floor, Orlando, Florida 32801, or at such place as shall be mutually agreed upon by COUNTY and OWNER.
- 3. OWNER agrees to remove any personalty from said Parcels before 30 days after the effective date. It is mutually agreed that any personalty not removed before 30 days after the effective date shall be deemed abandoned and COUNTY, or its contractors, may remove and dispose of said personalty. The property owner will have no further claim or interest in said personalty after this date without a written agreement between the parties.

- 4. Effective Date: This Agreement shall become effective on the date upon which it has been fully executed by the parties and approved by the Orange County Board of County Commissioners.
- 5. In exchange for OWNER's donation of the Property by Recreational Trail Easement to COUNTY, COUNTY agrees to the following:
 - a. COUNTY shall pay OWNER's attorney's fees in the amount of Five Thousand Seven Hundred Sixty Eight Dollars (\$5,768.00) no later than sixty (60) days following the Effective Date. Said fees shall be paid directly to Forster Boughman & Lefkowitz, 2200 Lucien Way, Suite 405, Maitland, Florida 32751.
 - b. COUNTY shall pay OWNER'S engineering fees in an amount not to exceed Seven Thousand Five Hundred Sixty-Nine and 18/100 Dollars (\$7,569.18). Said fees shall be paid directly to Florida Engineering Group, 5127 S. Orange Avenue, Suite 200, Orlando, Florida 32809 no later than sixty (60) days following COUNTY's receipt of an invoice approved by COUNTY and OWNER and consistent with the Scope of Services set forth in Schedule "B," attached hereto.

THIS AGREEMENT supersedes all previous agreements or representations, either verbal or written, heretofore in effect between OWNER and COUNTY, made with respect to the matters herein contained, and when duly executed constitute the AGREEMENT between OWNER and COUNTY. No additions, alterations, or variations to the terms of this AGREEMENT shall be valid, nor can provisions of this AGREEMENT be waived by either party unless expressly set forth in writing and duly signed.

1. <u>OBJECTIVE</u>

Orange County is in the process of finalizing plans and other civil engineering documents for Shingle Creek Regional Trail, Phase 1 Segment 3. The Shingle Creek Regional Trail (SCRT) is a multiuse recreational trail being developed through cooperation between Orange County, Osceola County, City of Orlando, and City of Kissimmee. Orange County's section begins at the Orange/Osceola County line and ends at Sand Lake Road. Phase 1 Segment 3 portion of the Orange County section is a 14-foot wide path from Taft Vineland Road to SR 528 along Shingle Creek. The trail path is planned to be on grade except for a small portion, which will consist of an elevated boardwalk.

Based on cursory review of the trail alignment and location, the trail is mainly situated on land owned by Grande Plaza Maintenance Associations, Inc. For the most part, this land is covered by conservation, drainage, and potentially other easements.

Grande Plaza Maintenance Association, Inc. has requested that Orange County engages Florida Engineering Group, Inc. (FEG) to review the engineering aspects of the trail design as they relate to the effects of the proposed trail on Grande Plaza Maintenance Association, Inc.'s property. WHEREAS, the Grantor is an Association responsible for managing certain common property ("Common Property") as more particularly described in the Declaration of Covenants, Conditions and Restrictions for Grande Plaza Maintenance Association, Inc., recorded at O.R. Book, 8173, Page 3806 in the public records of Orange County, Florida ("Grande Plaza Declaration"); and

WHEREAS, the Common Property is encumbered by the Declaration of Covenants, Conditions, Restrictions, Easements, and Reservations for Grande Lakes Master Stormwater Management System filed August 7, 2003, and recorded in Official Records Book 7038, Page 2091, in the public records of Orange County, Florida ("Stormwater Declaration"); and

Grantee shall have the right at Grantee's sole cost and expense, to clear and keep clear all trees, undergrowth and other obstructions that may interfere with the normal operation or maintenance of the Trail Segment and its Facilities out of and away from the Easement Area. Grantor shall have no obligation to maintain, service, repair, or replace the Facilities, unless such maintenance, service, repair, or replacement is necessary because of acts of the Grantor.

Grantor and Grantee agree to reasonably cooperate with each other to correct or modify the legal descriptions contained in Schedule "A" if necessary to address errors in the descriptions or to address other easements and/or title issues affecting the Easement Area.

Grantee agrees to defend, indemnify and hold harmless the Grantor and the Stormwater Association, their officials and employees from all claims, actions, losses, suits, judgments, fines, liabilities, costs and expenses (including attorney's fees) attributable to its negligent acts or omissions, or those of its officials and employees acting within the scope of their employment, or arising out of or resulting from the Grantee's negligent design, construction, or maintenance of the Facilities under this Easement, but excluding any losses attributable to the negligent acts or omissions arising out of or resulting from the Stormwater Association's negligent performance under that certain Grant of Drainage Easements and Bill of Sale filed August 3, 2005 and recorded in Official Records Book 8105, Page 3843, and that certain Corrective Grant of Drainage Easement and Bill of Sale filed August 30, 2005 and recorded in Official Records Book 8164, Page 103, and that certain Declaration of Covenants, Conditions, Restrictions, Easements and Reservations for Grande Lakes Stormwater Management System filed August 7, 2003 and recorded in Official Records Book 7038, Page 2091, all of the Public Records of Orange County, Florida. Nothing contained herein shall constitute a waiver of sovereign immunity or the provisions of Section 768.28, Florida Statutes. The foregoing shall not constitute an agreement by any party to assume any liability for the acts, omissions and/or negligence of the other parties. Grantee agrees that the Facilities shall comply with all applicable laws, statutes, codes, ordinances, rules, regulations, resolutions, limitations, restrictions, orders, judgments, decrees, or other requirements of any governmental body, agency or authority, whether federal, state, or local, having jurisdiction over the lands being conveyed by this Easement.

Grantee agrees that its use of the Easement Area and the Facilities will not adversely affect or interfere with the operation and/or maintenance of the Master Stormwater System or any other conservation and/or buffer easement areas located on the Common Property.

Grantor hereby reserves the rights of ingress, egress, use and enjoyment of the Easement Property at any time for any public purpose or as may be necessary to comply with its obligations under the Grande Plaza Declaration to maintain the Common Property, so long as such ingress, egress, use, and enjoyment will not unreasonably interfere with the rights conferred upon Grantee hereunder. Grantor shall not build, construct or create, nor give its consent to any other person or entity to build, construct or create any permanent physical improvements upon the Easement Area. Grantee agrees that the Stormwater Association also has the right of ingress, egress and use of the Easement Property to the extent necessary to perform and comply with its obligations to manage, operate, and maintain the Master Stormwater System as required by the Stormwater Declaration.

It is intended that the rights, privileges, and easements herein created, granted and confirmed unto Grantee and its successors and assigns shall run with the title to Grantor's Property in perpetuity and may not be changed, modified, amended, cancelled, or terminated except by an instrument in writing signed by Grantee, and the then record owner of the portions of the Property on which the Easement is located.
