#### ACTION REQUESTED:

Approval to award Invitation for Bids Y18-144-KB, Janitorial Services for Orange County Convention Center, to the low responsive and responsible bidder, A.C.A. Industries, Inc. d/b/a American Maintenance, in the estimated contract award amount of \$4,946,151 for a 3-year term. Further, request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

#### **PROCUREMENT:**

To provide janitorial services for common areas of the Orange County Convention Center. Services covered by this contract include daily cleanings of customer areas, as well as semiannual and annual cleaning of windows and high areas both inside and outside of each building.

#### **FUNDING**:

Funding is available in account 4430-035-0927-3170.

#### <u>APPROVALS:</u>

The Convention Center and Business Development Division concur with this recommendation.

#### REMARKS:

Fifteen bids were received in response to this Invitation for Bids, and were evaluated for responsiveness, responsibility and price reasonableness. UBM Enterprises, Inc., ACP Facility Services, Inc., and APDC Cleaning Services, Inc. were deemed non-responsible because they failed to meet the Qualification of Bidders requirements. Elite Enterprises of Gainsville, Inc. was deemed non-responsive because the bid response form was incomplete. The lowest responsive and responsible bidder, A.C.A. Industries, Inc. d/b/a American Maintenance, meets all of the requirements of this solicitation. Therefore, recommendation for award is made to A.C.A. Industries, Inc. d/b/a American Maintenance.
