## **ACTION REQUESTED:**

Approval to award Invitation for Bids Y18-1006-KF, Veterinary Clinic Supplies, to the lowest responsive and responsible bidder on a line by line basis, to Suncoast Surgical and Medical Supply, LLC as the primary source of supply for line items 1, 2, 8, 24, 26, 27, 28, 29, 31, 33, 34, 35, 40, 41, 45, 50, 53, 55, 57, 62, 64, and 65, and secondary source of supply for line items 18 through 23 in the estimated contract award amount of \$122,933.35, for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

## PROCUREMENT:

This contract will provide clinic supplies to support the care of animals in the custody of the Animal Services Division.

#### **FUNDING**:

Funding is available in account number 0001-060-2392-4144.

## APPROVALS:

The Health Services Department and the Business Development Division concur with this recommendation.

#### REMARKS:

Five bids were received in response to Invitation for Bids Y18-1006-KF and were evaluated for responsiveness, responsibility and price reasonableness. McKesson Medical-Surgical Inc., Interline Brands, Inc. dba Supplyworks, and Tronex International, Inc. were deemed non-responsive for amending the terms and conditions for delivery.

# Page 2 Y18-1006-KF, Veterinary Clinic Supplies

Interboro Packaging Corporation was awarded lines 18 through 23, and 66 within Procurement's authority. Two contracts are required to meet projected demands for these services.

The remainder of the lines received no bids and will be procured through a separate solicitation.

The lowest responsive and responsible bidder, Suncoast Surgical and Medical Supply, LLC met all of the requirements of this solicitation. Therefore, recommendation for award is made to Suncoast Surgical and Medical Supply, LLC.
