ACTION REQUESTED:

Approval to award Invitation for Bids, Y18-747-TA, Deerfield Boulevard Forcemain, to the low responsive and responsible bidder, Schuller Contractors Incorporated, in the estimated contract award amount of \$795,897.

PROCUREMENT:

The improvements include the construction of 4200 linear feet of 8-inch forcemain along Deerfield Boulevard between Pump Station 3468 and John Young Parkway. The installation of the forcemain will extend the useful life of the system and provide a more reliable pressurized wastewater system. This project is located in Districts 1 and 4.

<u>FUNDING:</u>

Funding is available in account number 4420-038-1539-6345.

APPROVALS:

The Utilities Engineering Division and the Business Development Division concur with this recommendation.

REMARKS:

Seven bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Valencia Construction Group, Inc. was determined non-responsible as their references did not meet the minimum requirements in the solicitation. Schuller Contractors Incorporated has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to Schuller Contractors Incorporated.

PROJECT: Y18-747-TA / Deerfield Boulevard Force Main

The Business Development Division evaluated the 3 lowest bids of the 6 bids submitted for this project and found that the apparent low bidder Schuller Contractors Incorporated did not achieve good faith effort documentation and reported 6.91% MWBE participation in their bid. Please note the following certified MWBE participation:

The second low bid submitted by DB Civil Construction, LLC did not achieve good faith effort documentation and reported 8.93% MWBE participation in their bid.

The third low bid submitted by Carr & Collier Inc. did not achieve good faith effort documentation and reported 11.61% MWBE participation in their bid.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.
