The contract performance periods will be for one year with two 1-year renewals.

PURPOSE

To select two firms to provide continuing professional services for annual traffic counts.

DISCUSSION

The Consultants will provide a variety of reports and studies, including traffic data collection services. The services to be conducted will include the collection of traffic count data to support Orange County's average annual daily traffic count program. procurement of reports, studies, and services for these contracts will be assigned as needed to accomplish a specific task for a described scope of services.
