Further request the Board authorize the Procurement Division to negotiate and award a contract provided that it does not exceed the budget of \$3,146,000.

## PURPOSE

To provide design services for the Orange County Convention Center West Building meeting rooms renovation.

## DISCUSSION

The West Building has meeting rooms on Levels 1 through Level 4 that were constructed as part of the Phases III and IV expansions completed in 1996. The scope of this project is to renovate the meeting room interior finishes, such as flooring, ceiling, walls, wall panels, air walls, signage, door hardware, and miscellaneous specialties. In addition to renovating these meeting room interior finishes, the scope includes upgrading HVAC, lighting, controls, and protecting the existing building systems (i.e. fire protection, audio system) while meeting local and federal regulations.
