REMARKS:

R & R Palmetto Avenue, Ltd. and Orange County entered into that certain "Parking Agreement" approved by the Board of County Commissioners dated October 21, 2014, which agreement was thereafter amended by that certain "Addendum to Parking Agreement" dated September 23, 2015 (collectively, the "Lease"). The Lease provides 46 reserved parking spaces and 182 unreserved parking spaces in the parking garage at 305 North Palmetto Avenue to allow employees of the Public Defender's Office, State Attorney's Office, Court Administration, and Clerk of the Court to park downtown near the Orange County Courthouse.

This "Second Addendum to Parking Agreement" extends the term of the Lease for three years, commencing October 1, 2018, and terminating on September 30, 2021, and establishes the quarterly rent for such extended term.

All other terms and conditions of the Lease shall remain in effect.

SECOND ADDENDUM TO PARKING AGREEMENT

THIS SECOND ADDENDUM TO PARKING AGREEMENT made and entered into this // day of September, 2018, supplements and modifies that certain Parking Agreement and Addendum to Parking Agreement between R & R Palmetto Avenue, Ltd., a Florida Limited Partnership, whose address is 105 East Robinson Street, Orlando, Florida 32801 (hereinafter referred to as "Owner") and Orange County, Florida, a charter county and political subdivision of the State of Florida, whose address is P.O. Box 1393, Orlando, Florida 32801, (hereinafter referred to as "County") dated September 30, 2014 and September 23, 2015, respectively.

- Applicability. To the extent that the provisions in the Second Addendum to Parking Agreement conflict with the provision in the Parking Agreement and Addendum to Parking Agreement, this Second Addendum to Parking Agreement shall control.
- 2. Duration of Agreement. The term of this Agreement shall be for an additional period of three years commencing October 1, 2018.
- 3. Rental. In lieu of paying Owner the rental fees on a monthly basis, County agrees to pay the Owner on a quarterly basis, as set forth in Exhibit "B", attached hereto and incorporated herein by reference, for forty-six (46) reserved parking spaces and one hundred eighty-two (182) unreserved parking spaces, commencing October 1, 2018.
