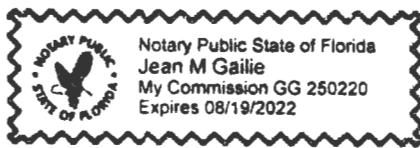

Applicant: Donn Sharpe, Springhill Planned Development / Springhill Phases 1B-2, 1B-3, 1B-4 & 1B-5 Preliminary Subdivision Plan, Case # CDR-18-06-208

Consideration: Substantial change request is to amend the Springhill Phases 1B-2, 1B-3, 1B-4 & 1B-5 Preliminary Subdivision Plan to grant a waiver from Orange County Code Section 38-1384(g)(2), to allow for a minimum garage setback from the nearest adjacent plane of the primary structure of zero feet in lieu of 10 feet for lots 162, 170, and 171 of the Storey Grove Phase 1B-2 plot only; pursuant to Orange County Code, Chapter 34, Article III, Section 34-69 and Chapter 30, Article 30, Section 30-89
