## ACTION REQUESTED:

Approval of Amendment No. 9, Contract Y7-517A, Renewal of Proprietary Software License and Maintenance Agreement for Financial Software (Advantage), with CGI Technologies and Solutions, Inc., in the annual amount of \$859,560.89. Further request authorization for the Procurement Division to renew the contract for four additional 1year terms in accordance with the maintenance fee schedule provided herein.

# PROCUREMENT:

Annual maintenance support for the Advantage software system provides the County with software enhancements, periodic software patches, diagnostic services, system documentation updates, online and telephone hotline support, and future software This application affects financial and subsystem users and supports operations in the following functions: finance (accounting, asset management, treasury accounting, and investments management), project and grants management, budget preparation, and procurement.

### APPROVALS:

The Information Systems and Services Division concurs with this recommendation.

# REMARKS:

The contract with American Management Systems, Inc. for software maintenance was approved by the Board on October 22, 1990, and has been renewed annually since that date. American Management Systems, Inc. was dissolved by corporate merger and is currently known as CGI Technologies and Solutions, Inc.

In July 2001, the Board approved the upgrade of the software to the web-based version of Advantage. This software is proprietary to CGI Technologies and Solutions, Inc. The previous agreement was set at 3% price increases per term. Industry standard ranges from 3% to 5%. The new agreement is set at a 1% price increase after the initial term and provides locked in costs for four, one-year terms with no future increases beginning in October 2019. Based on these factors, the price for these services is considered fair and reasonable.
