### **<u>RECOMMENDATION</u>**

Selection of four firms and two ranked alternates to provide Continuing Architectural Services, Request for Proposals Y18-907-EB, from the following firms listed alphabetically. Further recommend the Board authorize execution of the final contracts by the Procurement Division to establish hourly rates for future requirements. The contracts performance period will be for one year with two 1-year renewals.
