#### **Purpose**

- To discuss a redevelopment opportunity in Pine Hills
  - Involves collaboration between the Pine Hills NID,
    Orange County and Wendover Housing Partners
- To review the State's 2018 Request for Applications process for affordable housing



#### **State Funding Opportunity**

- State Funding
  - -Florida Housing Finance Corporation (FHFC) issued a Request For Applications (RFA) for Housing Tax Credits on September 6, 2018
  - -Applications are due October 30, 2018
  - -FHFC's RFA allows Orange County to select a project it determines is highly beneficial
  - -Selected project will receive extra points



#### **Required Local Contribution**

- Minimum required financial contribution \$567,500
- State Housing Initiatives Partnership (SHIP)
  funds will be set aside
- Selected project awarded Housing Tax Credits by the state will enter into Developer's Agreement for Local contribution



#### **NID Overview**

- Pine Hills Neighborhood Improvement District (NID) was established in 2011 to:
  - Redevelop key commercial corridors
  - -Create town center at Pine Hills & Silver Star Roads
  - -Stimulate economic investment
  - -Support neighborhood businesses
  - -Improve physical environment and eliminate blight

- 4/22/2017 BCC Approved PD Substantial Change to allow senior multi-family as a permitted use
- Favorable community support in Pine Hills
