Approval to award Invitation for Bids Y18-1142-TJ, Temporary Labor Services-Maintenance Technician, to the low responsive and responsible MWBE compliant bidder, Moten Tate, Inc., in the estimated annual contract award amount of \$165,637. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

PROCUREMENT:

The purpose of this procurement it to provide temporary labor for both long term and short term assignments to assist in meeting the employment needs of the Utilities Department.

REMARKS:

Seven bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted by Spur Employment, Inc. was determined to be non-responsible due to an unfavorable reference result.

Moten Tate, Inc. is a certified M/WBE firm whose bid is within the 7% allowed by the solicitation for award to other than the low bidder in accordance with the County's M/WBE Ordinance, Section 17-324.
