WHEREAS, the State of Florida Department of Transportation is constructing, reconstructing or otherwise changing a portion of the Public Road System, on VULCAN ROAD which shall call for the installation and maintenance of railroad grade crossing traffic control devices for railroad grade crossing over or near said highway; and
NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSION OF ORANGE COUNTY, FLORIDA;
That ORANGE County enter into a RAILROAD REIMBURSEMENT AGREEMENT with the State of Florida Department of Transportation and the FLORIDA CENTRAL RAILROAD COMPANY, INC.  Company for the installation and maintenance of certain grade crossing traffic control devices designated as Financial Project Number 442361-1-57-01 on VULCAN ROAD which crosses the right of way and tracks of the Company at FDOT/AAR Crossing No. 625278-G located near APOPKA Florida; and
That the County assume it's share of the costs for future maintenance and adjustment of said grade crossing traffic control devices as designated in the RAILROAD REIMBURSEMENT AGREEMENT; and  That the Mayor and Clerk of the Board of Commissioners be authorized to enter into such agreements with the State of Florida Department of Transportation and the FLORIDA CENTRAL RAILROAD COMPANY, INC.  Company as herein described; and
