### ACTION REQUESTED:

Approval to award Invitation for Bids Y18-1053-KB, Recycling and Waste Disposal Services, to the low responsive and responsible bidder, Waste Management Inc. of Florida, in an estimated contract amount of \$1,499,196.50 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

### PROCUREMENT:

The contract will provide waste disposal and recycling services for Orange County facilities and properties owned or leased by Orange County.

### FUNDING

Delivery Orders for services will be issued on an as-needed basis.

### APPROVALS:

The Facilities Management Division and the Business Development Division concur with this recommendation.

### REMARKS:

Six bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Advanced Disposal Services Solid Waste Southeast, Inc. was deemed non-responsive due to an incomplete bid response form. DisposAll, Inc. was deemed non-responsible for unsatisfactory performance and limited resources. Waste Management Inc. of Florida meet all of the requirements of the solicitation. Therefore, Waste Management Inc. of Florida is recommended for award.
