Subject: Award of Invitation for Bids Y18-1108-KB, Small Engine OEM Parts

ACTION REQUESTED:

Approval to award Invitation for Bids Y18-1108-KB, Small Engine OEM Parts, to the low responsive and responsible bidder, Trail Saw & Mower Service, Inc., for line items 5-7, 10, 13, and 15 for a 1-year term contract in the estimated contract award amount of \$254,000. Further request authority for the Procurement Division to renew the contract for four additional 1-year terms. This is an estimated contract amount and the annual usage is uncertain. However, the Fleet Management Division anticipates the entire estimated contract amount will be ordered during the initial contract term.

PROCUREMENT:

This contract will provide small engine OEM parts to support the maintenance requirements of multiple divisions within the County.

FUNDING:

Funding is available in account number 5530-043-2035-4163.

APPROVALS:

The Fleet Management Division and the Business Development Division concur with this recommendation.

REMARKS:

Two bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. This solicitation structured as a percent discount off the manufacturer's list price. Trail Saw & Mower Service, Inc. and Bray Ace Hardware met all of the requirements of this solicitation.

Price reasonableness has been confirmed based on comparison to the current contract discounts. Bray Ace Hardware bid solely on line item #15 – Stihl Products in an estimated amount of \$201,500 annually. Trail Saw & Mower Service, Inc. the low responsive, responsible bidder responded on five additional line items. Additionally, Trail Saw & Mower Service, Inc. bid a 5% greater discount (30%) for line item #15 – Stihl Products. This additional 5% discount has an anticipated annual savings to the County of over \$10,000.

Line items 1-4, 8, 9, 11, 12, 14, and 16-20 received no bids.
