ACTION REQUESTED:

Approval to award Invitation for Bids Y18-1146-AV, Labor for Orange County Convention Center, to the low responsive and responsible bidders, for the base year, in the total estimated contract award amounts listed below. Further request authorization for the Procurement Division to renew the contracts for option years one and two.

<u>APPROVALS:</u>

The Orange County Convention Center and the Business Development Division concur with this recommendation.

REMARKS:

Six bids were received in response to the Invitation for Bids (IFB) and were evaluated for price, responsiveness, and responsibility. Gemilang Solutions, A & Associates Staffing, Inc., and Taylor Smith Consulting, LLC were determined to be non-responsible for failing to meet the experience requirements as outlined in the Bidder Qualifications. A & Associates Staffing, Inc. was also deemed non-responsible based on past unsatisfactory performance.

In accordance with the IFB, the County reserves the right to make multiple all-ornone awards based on the results of this IFB. Due to the need to support multiple events simultaneously in all three Convention Center buildings, it is vital to have multiple contracts to provide these labor services. This contract will provide labor services for the Environmental Services and Event Services Divisions to supplement the Convention Center staff.

Staff performed a technical evaluation of the bids and determined that each low bid was reasonable based on performance and experience. The County shall award a primary contract to the lowest responsive, responsible bidder, Hire Quest, L.L.C. dba Trojan Labor, followed by awards to secondary Lyneer Staffing Solutions LLC, and tertiary AUE Staffing, Inc.

The primary shall be given the first opportunity to provide labor services, however, if they decline due to the inability to provide labor, the secondary, and tertiary, in consecutive order, shall be given the opportunity to provide labor services. The bidders were determined to be the low responsive and responsible bidders for the items listed and were recommended for award.
