ACTION REQUESTED:

Approval to award Invitation for Bids Y18-777-CH, Little Egypt Sidewalk Improvements, to the low responsive and responsible bidder, RMS Constructors Group, LLC, in the total contract award amount of \$685,359.50.

PROCUREMENT:

The project consists of the construction of five-foot wide sidewalks, drainage improvements, and driveways within Little Egypt. The affected roads are:

- Nome Drive
- South Street
- Roger Street
- Mercer Street
- Huppel Avenue
- Collier Boulevard
- Carter Street
- College Drive
- Ellis Avenue

Sidewalks will be constructed on one side of the road with crosswalks and ramps added at each crossing point and at road intersections. The project is located in District 6.

FUNDING:

Funding is available in account numbers: 1023-021-0193-6312.

APPROVALS:

The Engineering Division, Highway Construction Division, and Business Development Division concur with this recommendation.

REMARKS:

Three bids was received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted by CM Engineering Services Florida, PLLC was deemed non-responsible because the bidder submitted similar projects that did not include the required elements. Although the bid submitted by RMS Constructors Group, LLC is approximately 61% lower than the second low bidder, staff evaluated the bids and attributed the price difference to current market fluctuations and determined that the low bid was reasonable. RMS Constructors Group, LLC confirmed their price and understanding of the scope of work. References provided were satisfactory for this type of work. Therefore, award is recommended to RMS Constructors Group, LLC. The bid tabulation is as follows:

The Business Development Division evaluated the 2 bids submitted for this project and found that the apparent low bidder RMS Constructors Group, LLC met the MWBE participation goal and reported 27.95% MWBE participation in their bid. Please note the following certified MWBE participation:

The second low bid submitted by Gibbs & Register, Inc. did not achieve good faith effort documentation and reported 9.80% MWBE participation in their bid.

None of the bids were within the MWBE sliding scale range to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
