RECOMMENDATION

Selection of Hartman Consultants, LLC to provide Opinion of Value for Pluris Wedgefield, Inc., Water and Wastewater System, Request for Proposals Y19-801-TA. Further request the Board authorize negotiation and execution of the final contract by the Procurement Division provided that it does not exceed the budget of \$55,000.

The proposals were evaluated by the Procurement Committee on October 17, 2018. Commissioner Pete Clarke was assigned to the Procurement Committee.

PURPOSE

This project consists of providing support to Orange County Utilities regarding evaluation and pursuing the potential acquisition of the Pluris Wedgefield, Inc. Water and Wastewater System based upon the request received from the Wedgefield Homeowners Association. This project is located in District 5.

DISCUSSION

The Consultant shall provide the professional services associated with the project description and objectives in development of preliminary opinions of cost/value using publicly available data sources, assistance in the collection of data for utility systems, estimation of probable total project costs and project schedules, preparation and execution of testimony as an expert witness on behalf of the County, preparing reports presenting alternative solutions available to the County with the consultant's findings and recommendations, reviewing the layout of the existing facilities, operational data, studies, reports, agreements, and drawings pertaining to the project. The project is anticipated to occur in multiple phases. Specific scope elements for each phase will be negotiated and formalized in amendments to the contract to support the valuation, assessment and negotiations.
