Preservation and Revitalization Office The Neighborhood administers the Neighborhood Pride Grant Program that provides funds for citizen organizations to enhance the quality of their neighborhoods. The Neighborhood Pride Grants are available countywide in amounts ranging between \$1,500 to \$10,000. Neighborhood Pride Grant applications are accepted year-round and are reviewed monthly by the Neighborhood Grants Advisory Board (NGAB).

The NGAB is recommending the approval of Prima Vista Neighborhood (\$5,000), Creek Water Neighborhood (\$5,000), South Pine Run Neighborhood (\$5,000), Meadow Woods Village 1 & 2 Neighborhood (\$5,000), Vista Cove Neighborhood (\$5,000), and Village Green Neighborhood (\$5,000) Sign Grants (see Attachment A). The grant requests are displayed in greater detail in Attachments B, C, D, E, F, and G. The grant requests were reviewed by Orange County staff and presented to the NGAB for recommendation. The applications were reviewed based on project feasibility, organizational readiness, and benefit to the community. In addition, the applications were reviewed against the County's permitting requirements to ensure that the project would comply with appropriate County codes. Finally, the organizations are required to sign a letter of agreement recognizing their responsibilities throughout the grant process, document the appropriate match, and demonstrate an ability to maintain the project.
