

Charter Review Commission History



 1968 Florida Constitution gave charter counties "all powers of local selfgovernment not inconsistent with general law, or with special law approved by vote of the electors"

 Twenty charter counties – over 75% of the state's population



Charter Review Commission History

- November 1986 Orange County Charter approved by voters
 - Effective January 1, 1987
- The first charter mirrored the existing county government at the time, with five at-large commission members
 - Provided for single-member district referendum in the 1988 general election
 - Created a Charter Review Commission (CRC)
 - Appointed no later than September 1987 with recommendations by August 1988
 - Thereafter, to be appointed on 4-year cycles

RESOLUTION of the Board of County Commissioners creating the CHARTER REVIEW COMMISSION 2008 Resolution No. 2007-H-05

WHEREAS, Section 702 of the Orange County Charter requires the Board of County Commissioners to appoint a Charter Review Commission consisting of not less than eleven (11) members and not more than fifteen (15) members no later than February 1st of the year prior to a Presidential election year; and

Charter Review Commission Purpose

Three methods to propose charter changes

- Board of County Commissioners
- Citizen petition
- Charter Review Commission



- All must be approved by referendum
- CRC is "empowered to conduct a comprehensive study of any or all phases of county government"



Charter Review Commission Purpose

- CRC has convened eight times since inception
- CRC charter changes include:
 - Creation of 6 single-member county commission districts with a county mayor
 - Creation of Preservation Districts
 - Term limits, succession plans, dates for taking office, non-partisan elections
 - County minimum standards effective within municipalities regarding adult entertainment, environment, gambling



Charter Review Commission Purpose

- Other areas of CRC impact:
 - Consolidation of Services Study Committee
 - Citizen's Review Board
 - Certain Constitutional offices becoming County offices
 - Ethics provisions
 - Audit provisions
- Majority of CRC proposals have been approved by voters

Charter Review Commission Structure & Obligations

- Between 11-15 members
 - Must be county electors
 - No elected officials
- Convene on a 4-year cycle
 - Appointed no later than February 1 of the year prior to a presidential election
 - Must adjourn no later than Monday following the general election



Charter Review Commission Structure & Obligations

- Proposed amendments and revisions are placed on the ballot at a general election
 - Report of proposed changes to Clerk of BCC
 - An analysis of costs or revenues that might result and financial impact statement for each proposal
 - CRC must hold at least four public hearings to present proposals



Charter Review Commission Structure and Obligations

- Member Requirements:
 - Attendance at meetings from February 2019 until Sept/Oct 2020
 - one to three meetings per month
 - variety of public hearing locations
 - Compliance with Sunshine, public records and financial disclosure laws
 - Ability to receive/respond to electronic notifications and documents
