(2) At least 10 days before the BCC public hearing date, send notices of BCC public hearing by U.S. mail to owners of property within 300 feet of the subject property and beyond.

Advertising Language: Special Exception in the P-O zoning district to allow a private school with up to 20 children from grades K through 6th in 1 classroom. This is not a charter school.

Material Provided:

- (1) Names and last known addresses of property owners within 300 feet and beyond (*via email from Fiscal and Operational Support Division*); and
- (2) Location map (to be mailed to property owners).


Special Instructions to the Clerk:
